

## **INFORMATION TEXT ON PROCESSING OF PERSONAL DATA**

As Uluova İnşaat A.Ş., we would like to share with you the details of the "Personal Data Protection Law No. 6698," which was enacted to protect individuals' fundamental rights and freedoms, especially the right to privacy, and to protect personal data.

### **1. Data Controller**

In accordance with Law No. 6698 on the Protection of Personal Data (KVKK), your personal data may be processed by Uluova İnşaat A.Ş., acting as the data controller, within the scope described below.

### **2. Purposes for Processing Personal Data**

Your collected personal data may be processed in accordance with the personal data processing conditions and purposes specified in Articles 5 and 6 of the KVKK, for the purposes of ensuring the legal and commercial security of Uluova İnşaat A.Ş. and individuals in business relationships with Uluova İnşaat A.Ş., ensuring the implementation of Uluova İnşaat A.Ş.'s human resources policies, and determining and implementing commercial and business strategies.

### **3. To Whom and for What Purposes Can Processed Personal Data Be Transferred**

Your collected personal data may be: Your personal data may be transferred to our business partners, suppliers, companies we have relationships with, legally authorized public institutions, and private individuals, in accordance with the personal data processing conditions and purposes specified in Articles 8 and 9 of the KVKK.

Your personal data will not be used for purposes other than those specified above, and will not be shared with or transferred to third parties except in accordance with legal obligations and official institutions/organizations.

### **4. Method and Legal Reason for Collecting Personal Data**

Your personal data is collected by Uluova İnşaat A.Ş. in accordance with the legislation through various channels, such as partnerships, affiliates, and solution partners with whom we collaborate or have a contractual relationship.

Your personal data collected accordingly may also be processed and transferred for the purposes specified in Articles (2) and (3) of this Disclosure Statement, within the scope of the personal data processing conditions and purposes specified in Articles 5 and 6 of the KVKK.

### **5. Measures Regarding the Protection of Personal Data**

Uluova İnşaat A.Ş. We take all necessary technical and administrative measures to protect personal data.

As personal data owners, if you submit your requests regarding your rights to Uluova İnşaat A.Ş. using the methods listed below in this Information Notice, we will contact you as soon as possible and within 30 days at the latest following the evaluation of your request. However, if the Personal Data Protection Board stipulates a fee schedule, Uluova İnşaat A.Ş. will charge the relevant party the fee specified in the schedule.

Bu kapsamda kişisel veri sahipleri;

To learn whether personal data has been processed,

To request information if personal data has been processed,

To learn the purpose of processing personal data and whether it is being used in accordance with its intended purpose,

To know the third parties to whom personal data has been transferred, both domestically and internationally,

To request correction of personal data if it is incomplete or inaccurately processed, and to request notification of the action taken to third parties to whom personal data has been transferred,

Despite being processed in accordance with the provisions of Law No. 6698 and other relevant laws,

To request the deletion or destruction of personal data if the reasons requiring processing are no longer necessary, and to request notification of the action taken to third parties to whom personal data has been transferred,

To object to any detrimental outcome resulting from the analysis of processed personal data, especially automated analysis, of the data subject,

To request compensation for damages suffered due to unlawful processing of personal data.

### **Request Submission Management**

In accordance with the first paragraph of Article 13 of the KVKK (Personal Data Protection Law), you may submit your request regarding the exercise of your above-mentioned rights by attaching documents proving your identity and sending it via registered-and-certified mail (iadeli-taahhütlü mektup) or through a notary to the following address: Birlik Mah. 411.Sok.
